MESSAGE FROM THE BOARD

Dear colleagues, partners and readers,

We are happy to present this Annual Report for the year 2021-2022. Many months of the year were still under the shadows of the COVID 19 pandemic. The devastating second wave of the pandemic resulted in lakhs of deaths, huge economic losses and untold miseries on peoples and especially the poorest, aged and labourers. However, we are extremely proud of the amazing work that civil society organizations did during the period. They were engaged in a number of work from providing essential services and supplies to facilitating health facilities to hospital services. Their services in this challenging times earned generous praise from all quarters.

PAIRVI taking a call of the pandemic created a network of social workers, NGOs, health professionals and doctors which provided critical medical advice to the people along with delivering essential supplies like food, care product, medicines and advice. It also trained more than 50 workers for home based care in Bihar and Madhya Pradesh. The network also involved some Indian doctors based abroad happy to help people and communities virtually and telephonically. Many people received medical advice telephonically and in virtual forum organized by the network. The network continued and focused on child and mother care when the pandemic ebbed.

PAIRVI being a peoples rights organization also ensured that the calls of human rights is heeded. We looked at the situation of State Human Rights Commissions and functioning of the District Human Rights Courts in Chhattisgarh, Rajasthan and Uttar Pradesh. We also explored ways to strengthen PRIs in the wake of Panchayati Raj election in Bihar. Child rights has been one of our focus and we engaged different stakeholders on conversations (and actions) on children in prison and children in conflict with law.

Commitment to sustainability has been driving PAIRVI's work on environment, climate change and sustainable development goals. In recognition of our work Ajay K Jha was elected Global Co-Chair of the major Groups and other Stakeholders Coordination Mechanism (MGOS CM) on the HLPF/SDGs, which is a platform of all ECOSOC accredited organizations working on the SDGs with the United Nations. He participated and contributed to (virtually) a number of events in the High Level Political Forum on Sustainable Development in July. A delegation of PAIRVI, CECOEDECON and MAUSAM also participated in the UNFCCC COP 26 in Glasgow, Scotland. PAIRVI was also represented in Asia Pacific Peoples Forum and Asia Pacific Forum on Sustainable Development, and Asia Pacific Environment Forum of Ministers and High Officials. PAIRVI also led a track of

discussion on Nature for food systems Transformation, which contributed to Fifth United Nations Environment Assembly in Nairobi. A number of activities related to education and awareness, critical thinking, systems transformation and solutions on environment, climate change and sustainable development were also organized with youth, farmers, CSOs and policy makers at sub national, national, regional (Asia and the Pacific) and global levels to further the global south perspective and need of urgency.

We are extremely thankful to our donors, partners and supporters for their support and encouragement. We hope that the Annual Report will help you understand our work, our commitment and our perspectives. We remain eager to learn from your feedback, comments and suggestions

OVERVIEW

Second wave of covid 19 pandemic returned with more vengeance after a lull towards the end of the last year. The first quarter of the financial year (April to June 2021) was extremely deadly with number of deaths registered more than twice as compared to the first wave. There were lock down imposed in many states for several weeks with complete halt of all activities and mobility. The state and the society was in complete disarray and people in panic. India registered maximum number of daily infections and deaths in the world many times during this period. However, CSOs responded competently and were able to contain the damage and help the society in modest ways.

HUMAN RIGHTS PROGRAMME

PAIRVI also responded with urgency to the pandemic and formed local support groups in Bihar, Jharkhand and Madhya Pradesh. With the partners we were able to reach more than 3000 persons with emergency support for dry ration, medications, medical guidance. The programme also supported continued education of more than 1500 children at their doorstep with partners. A virtual network with reputed doctors (from India as well as abroad) was created which people could access with the missed call. The network engaged with children, women, pregnant women, CSOs and whosoever sought medical advice through regular webinars. PAIRVI also trained more than 100 volunteers to strengthen community solidarity, remove fear and misinformation and help management of mild symptomatic cases with home based care. A number of do yourself guides, posters and information material was also published.

In the second semester of the year when pandemic seem to be contained, PAIRVI also addressed capacity building and rights advocacy issues. A training on advocacy with adolescent girls was organized in Uttar Pradesh. Varanasi, Uttar Pradesh was also place for a youth dialogue with students of the BHU.

The work with the women beedi workers continued with their SHG on paper plate making. However, much progress could not be made due to restrictions on mobility and small gatherings at marriages and other social events.

More than 200 people from Banka and Jamui district of Bihar were also enrolled for e-sharm cards through camps.

A study was conducted on status of human rights commission and district human rights court in Chhattisgarh followed by an online Consultation attended by the CSOs, advocates, legal fraternity and representation from the SHRC.

However, the most valuable work during the period was ensuring release of 10 children from jails in Bihar. These children were erroneously put in regular jails as adults. However, after the release all of them have been transferred to observation home and correctional activities with them will take place in due course.

SUSTAINABILITY PROGRAMME

PAIRVI engaged in many activities either organizing them or participating in them to address issues of sustainability, sustainable agriculture and food security, climate change and sustainable development goals. PAIRVI participated in the COP 26 at Glasgow UK and organized two side events on “GCF and Climate Finance to the CSOs” and “Climate Crisis; Urgency and responses.” It also organized and engaged Indian CSO in a pre-cop discussion on the recently released IPP 6th reports.

PAIRVI also participated in preparations towards the 5th Asia Pacific Environment Ministers Meeting to be organized in October in South Korea. PAIRVI also led the track of “Food Systems Transition” towards the preparation of the UNEA 5.2. It also participated in Asia Pacific Forum on Sustainable Development organized by UN ESCAP. PAIRVI also participated in the UN High Level Political Forum organized by UN ECOSOC in New York in July 2021.

More than 25 CSOs from South Asia received capacity building on Advocacy and Engagement workshop organized in Kathmandu, Nepal. More than 120 youth were engaged in youth Climate Townhall in Bikaner and Jaisalmer, which discussed local manifestations of climate change, associated risks and resolutions with youth leadership. PAIRVI also addressed the closing ceremony of the Asia Pacific Youth Dialogue on Climate change, disaster risk reduction and role of youth.

PAIRVI has been an active member of the Asia Pacific Regional CSOs Engagement Mechanism (APRCM) and was involved in organizing Peoples Forum (Virtual) and participated in Asia Pacific Forum on Sustainable Development organized by UNESCAP.

PAIRVI was also invited to speak at the India International Science Forum organized at Goa and virtually in an event titled Climate Change and Carbon neutrality. PAIRVI was also part of a webinar on digital push in Indian Agriculture organized by several networks led by AASHA.
